Procedure

Grind the ingredients of phase B until the blend is homogeneous.

Add phase A and grind it lightly.

Add phase C and grind it until the blend is homogeneous. Fill the powder into godet and press with the desired pressure. The pressure for godet 24,5x22mm is 2x50 bars.

Notes
