# **Procedure:**

Mix the ingredients of phase A with appropriate stirring equipment (e.g. propeller stirrer) until homogeneous. Add dissolved phase B while stirring thoroughly until homogeneous. Press powders into godets with suitable powder press equipment (e.g. Kemwall, 145-155 bar for godet size 36 mm in diameter).

## **Notes:**

The beautiful mauve shade of this Eye n´ Blush Color is created by a combination of Colorona® SynBerry Pink, Colorona® Dark Blue and RonaFlair® Extender W. Timiron® Super Red brings a little reddish undertone to the color. The addition of RonaFlair® SynMica M improves the pay-off and causes a velvety skin feeling. Oxynex® ST Liquid improves the light stability of the carmine coated Colorona® SynBerry Pink. The powder can be applied at eyes and cheeks with an appropriate brush, if you like the color more intense on eyelid take a wet sponge instead.
