#### **Procedure:**

Solubilize the preservatives in water and add premixed phase C. Mix until a homogeneous gel is obtained. Add phase D into phase B/C and homogenize. Add phase A while moderate stirring and mix until homogeneous. Adjust the pH at 5.8-6.0 with phase E.
