Procedure:

Disperse Ronastar® Red Lights in the water of phase A. Add Carbopol Ultrez 21 slowly on surface of the water while stirring slowly. Stir until the Carbopol is hydrated. Add remaining ingredients of phase A while stirring. Add sodium hydroxide under moderate stirring until homogeneous. Finally add the predissolved phase C while stirring. Check pH value and adjust to approx. 6.3 if neccesary.
