### **Procedure**

Mix the ingredients of phase A in a beaker. Add phase B which consists of 8.00g of grinded sugar and 68.35g of non grinded sugar, to phase A and mix it. Then add phase C and mix strongly until the bulk is homogeneous.

# **Notes:**
