Procedure:

Disperse phase B2 into phase B1 until homogenous. Heat the whole phase B to 70-75°C. Heat phase A1 to 70°C. Disperse phase A2 in phase A1 (Dissolver disc). Heat the whole phase A to 70-75°C. Add phase A to phase B slowly while stirring. Homogenize. Cool down to 40°C and add phase C while stirring. Adjust pH value to pH 6.5 - 7.0.
