Procedure:

Mix all the ingredients of phase A together. Add phase B and mix until a clear lotion is obtained. Adjust pH to 5-6.5 with phase C.

Notes:

Shake before use. Keep away from heat.

Appearance : transparent lotion

pH : 5.8

Stability : 3 months at room temperature, 4°C and 45°C.
