Procedure:

Add RonaCare[®] Ectoin and pearlescent pigments to water. Slowly sprinkle Keltrol and Genuvisco into high speed mixing vortex to minimize agglomeration. Continue mixing until continuous gel system forms with no visible gel bodies. Add preservative.
