Procedure:

Mix the ingredients of phase B in a beaker. Add phase A and mix again. Then add phase C and mix strongly until the bulk is homogeneous. Pour the mixture into suitable packaging.

Notes:

Burnt Sienna is a salt body scrub with a warm red tone, reminiscent of the burning sand of the desert. Small amounts of the pearl effect pigments Colorona[®] Copper and Colorona[®] Sienna create this beautiful red shade. A slightly shimmering effect is highlighting this formulation, which can be applied on the body during shower and rinsed with water for a soft and exfoliated skin.
