Procedure:

Combine all ingredients of phase B and heat up to 60° C while stirring. Once the mass is homogeneous, add the pearlescent pigments of phase A while stirring. Then cool down to room temperature while moderate stirring.

Viscosity: 35 800 cP (Fungilab Expert, Spindle PB, 5 rpm) at 24°C. Stability: 3 months at room temperature, 4°C, 40°C and 1 week at 50°C
