#### Pigmentation

The PWC (Pigment Weight Concentration) in the dry film is indicated for each styling PWC = p / (p + b)p = total weight pigments (solid)b = weight binder (solid)In the dry state: Pigment / binder ratio = ( $\Sigma$  Pigment) / (Total solid content (wet form) - ( $\Sigma$  Pigment))
