#### **Base Coat**

1-component water-borne basecoat

Applied layer thickness: 12 – 16  $\mu$ m

#### **Clear Coat**

2K high gloss clear coat

Applied layer thickness 45 – 55 µm

#### **Pigmentation**

The PWC (Pigment Weight Concentration) in the dry film is indicated for each styling

PWC = p / (p + b)

p = total weight pigments (solid)

b = weight binder (solid)

In the dry state: Pigment / binder ratio = ( $\Sigma$  Pigment) / (Total solid content (wet form) – ( $\Sigma$  Pigment))

The stylings in our color inspirations are intended to demonstrate future effect color directions and possibilities. Although we have tried to make the formulations as realistic as possible, we cannot guarantee their full feasibility for on-line application.
