0.951% Xirallic® NXT M260-30 Leonis Gold

2.038% Meoxal® F120-30 Taklamakan Gold

1.470% Novoperm® Orange HL 70 TS

0.946% Kronos® 2190

% pigment in wet paint

Layer 2

2K high gloss clear coat

In the dry state:

Pigment/binder ratio = 0.39

PWC in dry film = 28.00%

TECHNICAL DATA

Base Coat

1-component water-borne basecoat Applied layer thickness: 12 – 16 µm

Clear Coat

2K high gloss clear coat Applied layer thickness 45 – 55 μm

Pigmentation

The PWC (Pigment Weight Concentration) in the dry film is indicated for each styling

PWC = p / (p + b)

p = total weight pigments (solid)

b = weight binder (solid)

In the dry state: Pigment / binder ratio = $(\Sigma \text{ Pigment})$ / (Total solid content (wet form) – $(\Sigma \text{ Pigment})$)
