## **TECHNICAL DATA**

#### **Base Coat**

1-component solvent-borne basecoat Applied layer thickness: 12 – 16 μm

#### **Clear Coat**

2K high gloss clear coat Applied layer thickness 45 – 55 μm

#### **Pigmentation**

The PWC (Pigment Weight Concentration) in the dry film is indicated for each styling

PWC = p / (p + b)

p = total weight pigments (solid)

b = weight binder (solid)

In the dry state: Pigment / binder ratio =  $(\Sigma \text{ Pigment})$  / (Total solid content (wet form) –  $(\Sigma \text{ Pigment})$ )
