Application Network China) in 2013, 2016 and 2017, respectively. The number of employees has grown from less than 100 in 2013 to over 300 in 2018 while the total surface area of the facilities is 51% greater than in 2013.

MDM Shanghai recently won the "Innovation Excellence Award" from the "40 Years On: Multinational Corporations and Shanghai" initiative by Shanghai Daily for the outstanding development of the Innovation Center Shanghai.
